Executive Summary

DoS updated the Establishment Census from 2018 with survey data collected in 2023 and some administrative data in 2024. This dataset will be used as a sampling frame for the coming years, until the new National Statistical Business Register (SBR) is available.

Using administrative data to identify in-active establishments is done, but DoS does not yet have access to detailed economic administrative data, so direct use of administrative data for imputations or direct compilation of statistics is not yet possible.

Together with DoS experts, it was concluded that the remaining activities in component 3 should focus on guaranteeing good quality survey data in the coming years by:

- 1. Ensuring good quality sampling frame and suitable sampling methods,
- 2. Improving data validation, editing, and imputation methods and practices,
- 3. Renew the survey questionnaire to reduce response burden, improve data coverage, increase the quality and improve the applicability of data for the national accounts.

STEs also recommended:

- To obtain more comprehensive admin ID information for survey data to enable broader use of administrative data, either as auxiliary data or to aid in imputation and estimation when economic administrative data becomes available for DoS.
- Revise economic data regularly when new or corrected data becomes available, as recommended for ESS statistics.
- Be aware that administrative data does not cover the entire economy.

1. General comments

This mission report was prepared within the Twinning Project "Strengthening the capacity of Jordan's Department of Statistics in terms of compilation, analysis and reporting of statistical data in line with International and European best practices". The current Mission is carried out as part of component 3 - Strategy for missing or erroneous data.

The purpose of this activity was:

- To review current situation in Jordan related to the Mandatory Results.
- To obtain a common understanding of current situation, vision and challenges in relation to the Mandatory Results of this component
- To assess the level of compliance with relevant EU regulations and other international standards.

The consultants would like to express their sincere thanks to all officials and individuals met for the kind support and valuable information which they received during the stay in Jordan and which highly facilitated their work. The views and observations stated in this report are those of the consultants and do not necessarily correspond to the views of the EU, Statistics Finland or Statistics Denmark.

2. Assessment and results

The currents status on relevant work related to component 3 was reviewed and these were the main points:

- DoS updated the Establishment Census from 2018 with data collected in 2023 and some administrative data in 2024
 - Establishments in blocks with more than 35 establishments where updated by surveys in 2023.
 - o Some blocks with minor activity were not updated.
 - o The planned collection in 2024 was postponed.
 - Approximately 1000 blocks + update of approximately 2000 establishments + newly established blocks. Total = 178.000 active establishments (previously 168.000).
- Use of Administrative data
 - The Greater Amman/Local Administration data was used to remove the inactive units from the Census 2018 dataset.
 - The use of turnover data from VAT data is not possible because of legal limitations with Tax authorities.
 - o The Companies Control Department (CCD) collects data where turnover and other financial statement data can be generated on the International Standard Industrial Classification of All Economic Activities, ISIC 4, activity level.
- Further use of administrative data
 - DoS has been working on linking administrative identification numbers (ID) to the units in the Enterprise Census 2018.

- DoS experienced problems with respondents not being willing to answer questions about ID numbers. One example is a block with 5000 units where only 1000 units revealed the ID number.
- o For 22.000 (large establishments) out of 178.000 the IDs have been identified
- Automatic merging by IT support of administrative data with the updated 2018 frame have not been tried yet
- DoS does not yet have access to detailed economic administrative data, so further development of advanced use of administrative data is a priority for the longer term.

It was found that at this point, DoS would benefit the most from advice and assistance in:

- Forming a sampling frame for economic surveys and drawing a sample for the coming years, until the new National Statistical Business Register (SBR) is available for this purpose. (The development of SBR is supported by the component 1 of the Twinning project.) This task is complicated by the upcoming revision of the sampling strata, which is still in the planning stage. Assistance would be particularly needed in widening the knowledge on different sampling methods.
- Validating, editing, and imputing missing economic data.

It would be beneficial to familiarise with different methods and also consider situations where imputation should not be performed. (In practice, item non-response is not a problem, as the interviewer collects information until the form is fully completed.) The quality of imputation could be improved by utilising administrative data. Currently, available economic admin data is still scarce, but it might already be possible to test the utilisation of such auxiliary information. The challenge is that administrative ID is currently known for only certain surveyd establisments. Unfortuntely only small part of the respondents agree to provide this information, and they are not obliged to do so, but these could be a starting point.

• Updating economic survey questionnaires,

as currently their completion requires respondents to provide a wide range of information about the establishment's finances, often necessitating multiple visits by the interviewer to the respondent. The challenge, in addition to the number of questions, is that some questions are quite complex and may not be answerable based on standard accounting records. The collected data and terminology also partially align with the concepts and items of national accounts, which is challenging for respondents. Therefore, DoS has begun redesigning the survey questionnaires. It has also been noted that smaller establishments do not need to be asked for as much information as larger ones.

There are still many unachieved results remaining in the component 3 relative to the available time. It was therefore concluded that the objectives should be prioritised. Mandatory Result (MR) 3.3 was considered less critical by DoS compared to other Mandatory Results, and thus no activities were planned for this sub-component. The common understanding was that allocating more time to directly applicable topics would be beneficial to ensure they are sufficiently addressed and to allow for effective absorption of all the new methods and practices presented and discussed.

STEs also gave presentations on

• National Accounts, Business Register and Exhaustiveness in Statistics Denmark

• Key data sources and sampling strategies for Business Statistics in Finland

There was a lively discussion around these presentations and main subjects included: 1) The data requirements in the EU illustrated by Eurostats: ESA transmission program for National Accounts. 2) Ensuring that Censuses and Surveys cover the full economy. Administrative data does not cover all economic activity so it is important to maintain the ability to describe the informal economy that is not covered by administrative data. 3) Revision practices. EU countries regularly revise business statistics and national accounts. The regular calculation and analysis of revisions are an important part of statistical quality work. The STEs briefly presented the common EU practices and formulas for calculating the indicators.

3. Conclusions and recommendations

Based on the discussions and information provided by DoS experts, it was concluded that the remaining activities in component 3 should focus on guaranteeing good quality survey data in the coming years by:

- 1. Ensuring good quality sampling frame and suitable sampling methods
- 2. Improving data validation, editing, and imputation methods and practices
- 3. Renew the survey questionnaire to reduce response burden, improve data coverage, increase the quality and improve the applicability of data for the national accounts.

These priorities were used to revise the activity plan for component 3, which was updated during this activity. The revised plan is included as an <u>annex</u>.

STEs also recommended the following:

- It would be beneficial to obtain more comprehensive admin ID information for survey data to enable broader use of administrative data, either as auxiliary data or to aid in imputation and estimation when economic administrative data becomes available for DoS. Therefore, STEs suggest to improve the coverage of administrative IDs in the survey data. This can be done gradually. Broader coverage of admin IDs would also allow for more reliable comparison of survey and administrative data since information could be matched at the unit level. It would be useful to experiment with different matching information, including the use of multiple identifiers. Determining the administrative business IDs for the remaining establisments where matching was unsuccesfull might be assigned to interviewers, who would use various registers to deduce correct IDs.
- Revise economic data regularly when new or corrected data becomes available, as
 recommended for ESS statistics. It is also advisable and considered good practise to
 calculate and analyse data revision regularly. More information on recommended
 practices and calculation of revision indicators can be found in the ESS Handbook for
 Quality and Metadata Reports.
- Be aware that administrative data does not cover the entire economy. It is important to continue to be able to describe the informal economy, which is not covered by administrative data.


The current status is that the microdata for the following sources has been received and that metadata is currently being prepared and will be provided before the Mission

- The Ministry of Industry and Trade (MIT) (16 variables)
- o The Companies Control Department (CCD) (10 variables)
- The Social Security Corporation (SSC) (28 variables)

Even though the Income and Tax Department has been identified as essential DoS has not been able to receive microdata data from the Income and Tax Department. The obstacle for the lack

of data from the Income and Tax Department is that according to the law, the Income and Tax Department is only allowed to provide data to four institutions and DoS is not one of them.

StatBuS – The supporting IT system for building a SBR in Jordan

Currently, StatBuS is the supporting IT system being tested in Jordan. StatBus is the a client-server based system for statistical business registers which is an important backbone of any national statistical office. For additional information, please consult: https://www.StatBus.org/

The main features are:

- A tool for storing and maintain information on businesses from administrative sources, surveys and censuses
- Licensed as open source
- Based on UN international guidelines for development and maintenance of statistical business registers
- Used for drawing samples and make national economic statistics
- Important for National Accounts

The status for StatBus currently is that StatBuS has been successfully installed on a DoS server and test populations and key classification was uploaded to the system. Furthermore, it has been proved that the system support both Arabic and English.
